James (Jim) Cavallaro is a Visiting Professor at UCLA School of Law and will be teaching *Regional Human Rights Protection: The Inter-American System* in the Spring 2021 semester. Cavallaro is the Executive Director of the University Network for Human Rights. In June 2013, Cavallaro was elected to the Inter-American Commission on Human Rights. He served as President of that body from 2016-2017. Professor Cavallaro has dedicated his thirty-year career to human rights advocacy. A prolific scholar and sought-after voice on international human rights issues, he is frequently called upon by the media and civil society to offer his expertise.

José Miguel Vivanco is the Director of Human Rights Watch's Americas division, is a general expert on Latin America. Before joining Human Rights Watch, Vivanco worked as an attorney for the Inter-American Commission on Human Rights at the Organization of American States (OAS). In 1990, he founded the Center for Justice and International Law, an NGO that files complaints before international human rights bodies. Vivanco has also been an adjunct professor of law at Georgetown University Law Center and the School of Advanced International Studies at John Hopkins University. He has published articles in leading American and Latin American newspapers and is interviewed regularly for television news.



Maria Patricia Arce Guzmán (Quechua) is a Bolivian lawyer and was mayor of Vinto, department of Cochabamba, Bolivia between 2015-2020. In October of this year (2020) she was elected Senator for the department of Cochabamba with the Movement to Socialism party. In 2018 she received the International Maya Award, awarded to the best public servants for their contribution to development.



Claudio Nash Rojas s a legal scholar at the Faculty of Law of the University of Chile. He is a graduate in Legal and Social Sciences (Universidad de Chile, 1998) and Doctor in Law (Universidad de Chile, 2008). He served as a consultant on corruption matters to the Inter-American Commission on Human Rights (2018-2019). He is Director of the Series "Jurisprudence of the Inter-American Court" of the Inter-American Court of Human Rights (2014-2020), and founder and coordinator of the Study Group "Constitutional Justice and Fundamental Rights" of the Rule of Law Program of the Konrad Adenauer Foundation (2009-2020). He currently directs a project on "Constitution and Human Rights" within the framework of the constitutional process in Chile.



Silvia Serrano Guzmán is the Associate Director of the Healthy Families Initiative at the O'Neill Institute for National and Global Health Law, Georgetown University. Guzmán is also Adjunct Professor and SJD Candidate at the Law Center. She holds an LL.M in International Legal Studies with a Certificate in International Human Rights Law (Georgetown University) and a Master's degree in Legal Argumentation (University of Alicante). Before joining the Institute, she was the Coordinator of the Case Section at the Inter-American Commission on Human Rights (IACHR). She was also responsible for the litigation of cases submitted to the Inter-American Court of Human Rights (IACHR).
